Note:-

- Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed 3 years.
- Preference in deputation will be given to the officials of ICAR system.
- The departmental officials in the feeder category, who are in the direct line of promotion, shall not be eligible for consideration or appointment on deputation.
- The maximum age limit for appointment on deputation/deputation (including short terms contract) shall not exceeding fifty-six years' on the closing date of receipt of application.
- The official, who initially comes on deputation and considered suitable for the post, may be permanently absorbed by the appointing authority if no incumbent is available in the feeder cadre, in accordance with guidelines of DoP&T/GoI and the parent Department agrees to the proposal of permanent absorption.

It is requested that the vacancy may please be circulated amongst the eligible and desirous candidates, working at your Institute and also in regional stations. Application of only such candidates who can be relieved immediately in the event of their selection may please be forwarded in the enclosed proforma along-with the attested copies of APAR for the last 5 years. A certificate to the effect that no disciplinary/vigilance case is pending or being contemplated against the candidate(s) along with integrity certificate may also be furnished while forwarding the application through proper channel.
