

CONDITIONS

1. **Packing** : The material should be packed in clean and sound jute bags. The mouth of each gunny bag shall be either machine stitched or rolled over or hand stitched with strong jute twine.
2. **Marking** : Each bag should be suitably marked to indicate (a) either the name of manufacturer or supplier (b) Net weight in kg.
3. The supply will be accepted on net weight basis.
4. The supply will be accepted only on working days (from 10 AM to 2.30 PM).
5. Empty bags will not be returned.
6. For moisture, clay, straw and non-food grains deduction will be made at full rate.
7. Prorata deduction in payment will be made for short fall in analytical composition only upto rejection level.
8. The purchaser reserves the right to increase or decrease the quantity of the items/goods in the schedule of requirement up to 25% without any change in the unit price or other terms and conditions.
9. If the material is not found to be acceptable due to physical or chemical analysis, the rejected bags must be lifted within fifteen (15) days from the date of intimation for the same. Failing which a penalty/demurrages @ Rs.1 (Rupees One only) per bag/day will be charged upto a period of thirty (30) days only. After that the Institute will not have any responsibility for storing the material.
10. The liquidation charges will be imposed on late supply as per tendering terms.
11. 100% payment will be made after receiving the analysis report.
12. Performance security @ 10% of total contract value in the shape of T.D.R./F.D.R. only (valid atleast 3 months) shall be deposited immediately but not later than 15 days from the date of issue of award of contract, failing which the bid security will be forfeited.
13. Weighment will be made at Dharam Kanta as feasible to the feed grains and ingredients weighment committee. The contractor shall inform prior a day from the date of arrival of the material for proceeding the committee for weighment.
14. Excess/Short quantity will not be accepted.
15. Due to urgency of the item, if supply is late, the purchase will be made at the risk and cost of the contractor and if deemed fit, the firm may be debarred for a suitable period.
16. The applicable taxes i.e. VAT Charges will be deducted at source from the bills.
17. The payment shall be made on receipt of sufficient fund from the Council.
